IMPARTIAL ANALYSIS BY DISTRICT COUNSEL MEASURE A

This measure seeks voter approval of a very low interest loan to San Lorenzo Valley Water District from the State of California.

The State legislature adopted special legislation authorizing the District to borrow up to \$1.5 million at approximately 3.4% interest, and to seek voter approval by mailed ballot. Loan proceeds will be used exclusively to pay off debts resulting from denial by the State of California of grant-funding-for-construction of a wastewater system in the Valley. The District would be prohibited from planning, designing, acquiring, constructing or operating any sewage facilities (except those existing at Bear Creek Estates) during the term of the loan.

The loan will be repaid over 15 years from regular District revenues, and no increases in existing taxes, rates, fees or charges is anticipated.

Some creditors of the District have sued the District to recover what is owed to them. Approval of this loan would save attorney's fees and other litigation expenses for the District. The very low interest rate on the loan is estimated to save District residents almost \$300,000 over the cost of repaying these debts by other means, and will reduce the number of years' charges to be billed from six to five, saving about \$120 per bill payer.
