## ***CCF Mission Statement***

*Santa Cruz Public Libraries, in partnership with The Sheriff's Department, are committed to delivering programs and services for educational and personal development, to promote reentry success, as well to ease stress caused by incarceration, leading to an enriched and safer environment for people who are incarcerated, jail staff, and all Santa Cruz County residents.*

# CCF: Where We Serve

- **SC Main Jail**
  - Average population 280
  - CCF serves approx 80 a month
- **Rountree Medium Facility**
  - Average population 27
  - CCF serves approx 20
- **Rehabilitation & Reentry Facility**
  - Average population 42
  - CCF serves approx 25
- **Blaine St. Women's Facility**
  - Temporarily closed
- **Juvenile Hall**
  - Average population 24
  - CCF serves approx 20



# CCF: Who We Serve

- Demographics of Jail Population\*
  - 4.8% Black
  - 35.1% Latino
  - 57.3% White
- Demographics of Juvenile Arrests\*
  - 3.2% Black
  - 66.9% Latino
  - 25.6% White
- SC County Demographics\*\*
  - 1.5% Black
  - 34% Latino
  - 87% White

# CCF: Equity in action

## Library Services to People Who Are Incarcerated:

- Encourages a life-long relationship with the library, so that individuals & families may benefit from library services & programs throughout their lives after incarceration
- Promotes reentry success
- Eases the stress of incarceration
- Creates a positive relationship with the community
- Provides services to those who may not otherwise have access

**Nearly 50% of all adults in the US have an immediate family member that has been incarcerated in jail or prison for at least one night, this percentage is higher for Black and Latinx adults (Enns et al., 2019)**

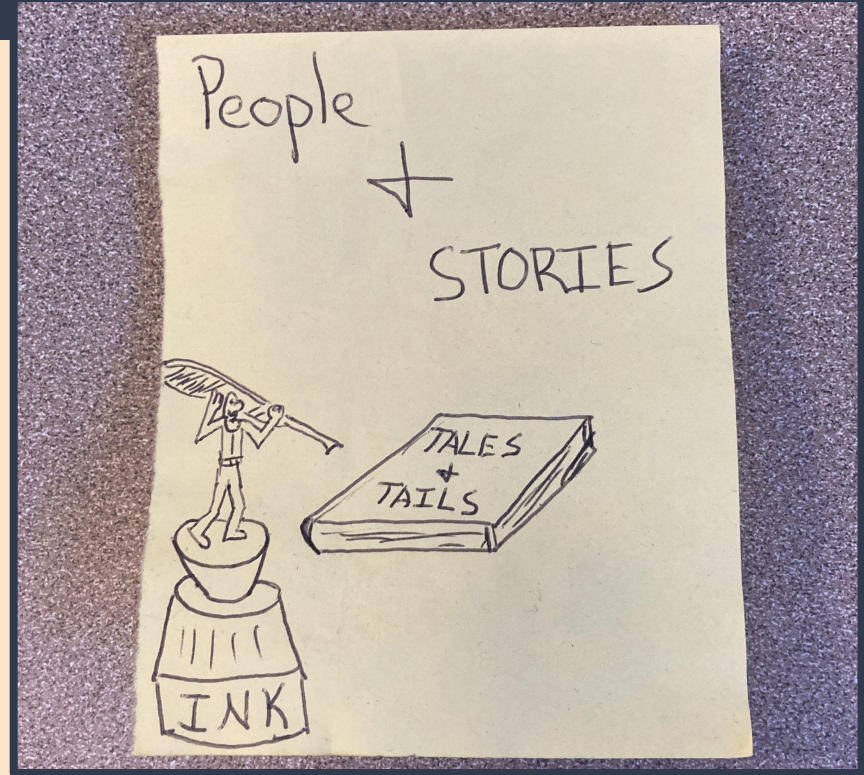

# CCF: People & Stories

- Introduces marginalized populations to relevant literature
  - Develops self-confidence, conflict resolution, & self-expression
  - Participants receive a MileStone certificate after 12 classes
- MileStones can be used to earn an earlier release





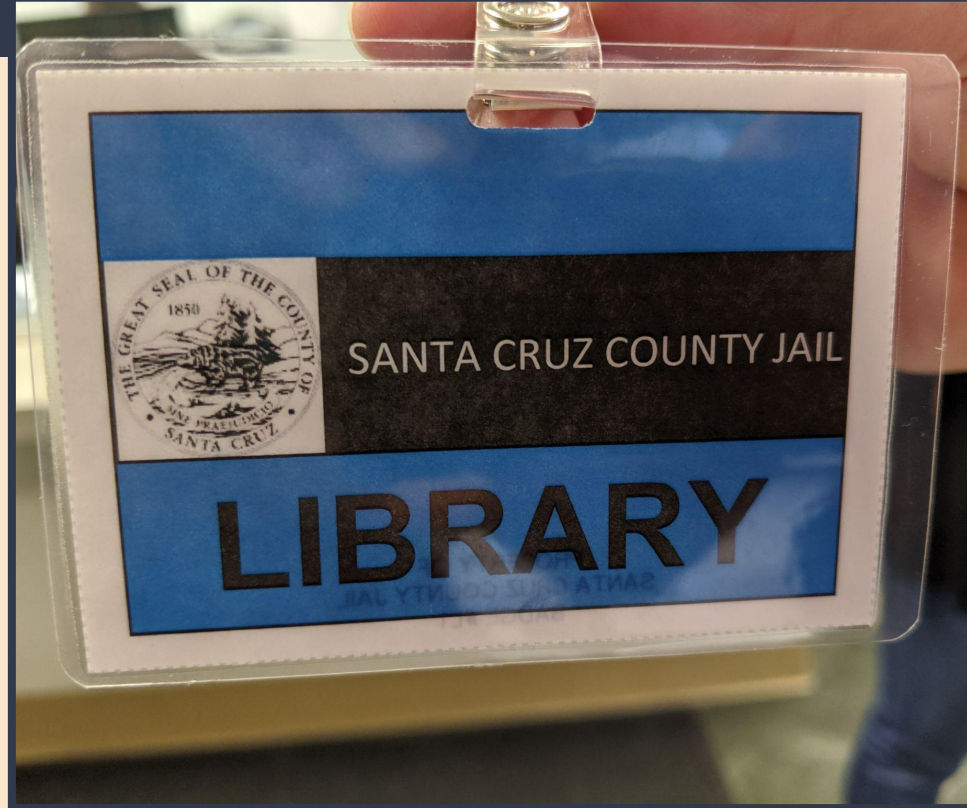
# CCF: Special collection of books

- Annual Budget of \$6000.00
  - Sheriff's contributes \$3000.00
  - SCPL contributes \$3000.00
- Collection Highlights
  - ~ 800 titles
  - ~ 200 Spanish language titles
  - ~ 600 English language titles
  - ~ 200 paperbacks for Juvenile Hall
