Jack Nelson – Concerned about building another parking garage in Downtown Santa Cruz. Advocates for more sustainability and improved public transit.

Jean Brocklebank – Favors a remodel of the existing library.

Susan Work – Expected that voting for Measure S meant an improvement of the existing library building.

Dana Baqshaw – Very active in climate change issues and also with the campaign for sensible transportation. Advocates for a green city so her vision for the library downtown does not have a parking garage above it.

Judi Grunstra – Hopes the committee revisits the option to utilize the present site. Believes the public should have been asked sooner in the process about what they thought about the idea of combining the library with a parking garage.

Reed Searle – Comments that one of the most important aspects of a library are its books and hopes the committee does not forget about the books.

Alene Smith – Concerned about the parking garage idea and advocates for more public transportation options.

Erica Stanojevic – As a bicyclist is concerned about the combined library with a parking garage. Encourages the committee to seek out the other options. Believes the city's climate goals will not be met with a parking garage.

Mark Lee – Also thought that voting for Measure S meant the money was going strictly to the current building. Voiced concerns about the future of the farmer's market.

Colonel Terry Maxwell – Stated that the current building can be renovated at a fraction of the cost.

Mary Bailey – Against the parking garage.
