
November 2017 Library Director's Report

Important Dates

All libraries will be closed on November 10 and 11 for Veteran's Day and November 23 and 24 for the Thanksgiving holiday.

Library Operations

Over 100 people came to the Jubilee Celebration in honor of 50 years of library service at the Branciforte Library on October 7. The gentleman below also attended the opening ceremony in 1967.



Library Staff Day took place on October 9 at the Happy Valley Conference Center. Over 100 staff members attended. Nina Simon gave the keynote address. Staff were very excited about the Innovation funding provided by the JPA. A process for distributing the grants is being established using the "pitch and idea" format of the Pacific Library Partnership. Grants should be awarded in December.

SCPL held an amazing program on October 13th in partnership with the Cabrillo Chorus, which brought California Poet Laureate Dana Gioia and National Medal of Arts composer Morten Lauridsen together for two programs. The first program for children attracted 45 participants for an interactive conversation about poetry and music. The evening program for adults also featured conversation between the poet and musician.



Members of the Cabrillo Symphonic Chorus, Cantiamo Cabrillo, and the Cabrillo Youth Chorus also performed poems by Mr. Gioia set to music by Dr. Lauridsen. More than 100 people attended this wonderful event.



Library Building Projects

Noll and Tam has completed the design development for the Capitola Branch Library. SCPL is working on a plan for closure including the transfer of the collections and staff, temporary expansion of hours at Live Oak and Aptos branches, a surplus furniture and book sale, programming at the mall in Capitola during the construction, and transfer of Library patron accounts to other locations.

The Felton project continues to undergo value engineering. The Felton Friends group is working with the County and Friends organization to find additional resources.

The County Supervisors approved the issuance of an RFP from architects for the Live Oak Library Annex to be located in the Simpkins Swim Center complex.

The Santa Cruz Downtown Branch Library Committee has begun to evaluate the cost implications of various scenarios. The Santa Cruz City Council will complete a tour of the Los Gatos and Downtown libraries on November 7 beginning at 9 a.m. The tours will be open to the public.
